

STYGIAN MEDIA PARTNER AGREEMENT

This Partner Agreement (“Agreement”) is made between Stygian Media (“Company”) and _____ (“Partner”). Both parties agree to the following terms:

1. ROLE & PARTNER STATUS

1.1 The Partner is an independent content creator who manages their own channel and production.

1.2 The Partner is not an employee, contractor, agent, or representative of the Company.

1.3 This Agreement provides network access, visibility opportunities, and community benefits without any control over the Partner’s content, platform, or monetisation.

2. FEES, PAYMENT & TERM

2.1 The Partner pays a fee of \$50 CAD per month.

2.2 Payments may be made by e-transfer or PayPal to the Company’s designated account.

2.3 This Agreement operates on a month-to-month basis, automatically renewing unless cancelled.

2.4 Cancellation may occur at any time by written notice (email accepted).

2.5 If the monthly fee has already been paid and the Partner cancels mid-month:

- No refund is issued for that month.
- The Partner retains access to network benefits until the end of the paid month.
- Refunds are only granted if Stygian Media fails to deliver any of the services outlined in Section 3 for an entire month through no fault of the Partner, including:
 - Failure to display the Partner’s profile on the Partner Page of the website,
 - Failure to feature the Partner as a Highlighted Creator if selected, or
 - Failure to include Partner content in agreed network promotional opportunities.

3. SERVICES PROVIDED BY STYGIAN MEDIA

While the Partner’s payments are current and the Agreement is active, Stygian Media will provide the following:

3.1 Visibility & Placement

- A profile on the Partner Page of the Stygian Media website, including a link, brief bio, and promotional image (as provided by the Partner).
- Highlighted Creator placement on the Stygian Media YouTube channel homepage.
 - Maximum six (6) Highlighted Creators at one time.

- If the partner count exceeds six, Stygian Media may:
 - Rotate creators on a scheduled basis, or
 - Introduce a premium tier or optional upgrade for continued access.
- Stygian Media will provide at least 30 days' written notice before any rotation or tier changes.

3.2 Social Media Interaction

- Stygian Media will share posts on Instagram, Facebook, or YouTube Stories where the Partner tags Stygian Media, provided the content aligns with network standards.
- Inclusion in community round-up posts, recommendation lists, or network updates when relevant.

3.3 Livestreams, Events & Community

- Invitation to network livestreams, with participation based on schedule and content suitability.
- Invitations to seasonal events and community activities.
- Montreal-based Partners may have access to local, in-person meetups and gatherings when available.

3.4 Network Communication

- Access to the private Stygian Media Facebook group for partners.
- Access to partner communications, update notices, and internal information relevant to collaborations, opportunities, and event planning.

Note: Services depend on scheduling, platform availability, and content suitability. No specific level of audience growth, view counts, or financial results is promised.

4. PARTNER RESPONSIBILITIES

The Partner agrees to:

- Maintain responsibility for their own channel, uploads, and monetisation.
- Provide accurate information and usable media files when promotional material is requested.
- Avoid behaviour that may cause reputational harm to Stygian Media or other partners.
- Respect community rules and other participants.

5. OWNERSHIP, RIGHTS & CONTENT USE

5.1 The Partner retains full ownership of their content, channel name, and monetisation.

5.2 Stygian Media may repost excerpts or clips of Partner content only in connection with livestreams or

group events the Partner participates in, for promotional purposes with proper credit.

5.3 No intellectual property rights are transferred under this Agreement.

5.4 Nothing in this Agreement implies endorsement, affiliation, or sponsorship of the Partner's content beyond the services described herein.

6. APPLICATION & REVIEW

6.1 All partner applicants are subject to review.

6.2 Acceptance is not guaranteed; placement depends on community fit and content suitability.

6.3 The Company may end the partnership if the Partner's conduct or content conflicts with the network's standards.

7. LIABILITY & INDEMNITY

7.1 The Company is not responsible for platform penalties, earnings changes, audience shifts, algorithmic issues, or third-party disputes. Participation is voluntary.

7.2 The Partner agrees to indemnify and hold harmless Stygian Media from any claims, damages, or disputes arising from the Partner's content or conduct.

8. GOVERNING LAW & DISPUTE RESOLUTION

8.1 This Agreement is governed by the laws of the Province of Quebec, Canada.

8.2 Any disputes arising from this Agreement shall first be addressed in good faith through negotiation.

8.3 If unresolved, the parties agree to submit the dispute to mediation before initiating legal proceedings.
